

## **USE AND REDISTRIBUTION POLICY FOR ACES**

**NOTICE OF AGREEMENT:** The ACES software and related information is free to law enforcement and related agencies **ONLY**. By signing this form, requesting access to the ACES web site, and downloading any utilities, data, documents, etc., contained within the site you agree to the following:

1. You are a valid representative of a law enforcement agency, or other qualifying government entity, and have proper authority to request such access.
2. You will **NOT** redistribute any ACES related material to persons not within your agency (you may freely distribute within your own agency).
3. Distribution of ACES related materials, for training classes, conferences, or other agency sponsored events, must be approved by the ACES Program Manager. You can contact the ACES Program Manager at [acesadmin@acesle.org](mailto:acesadmin@acesle.org).
4. Redistribution of any ACES materials must contain the ACES name and any version and/or date information of original material.
5. Any reference or quote from ACES material must include the version number and/or date of the original material and mention if the material is in beta or draft status.
6. The name of ACES, or its contributors, may not be used to endorse or promote products derived from its materials.
7. ACES materials will **ONLY** be used in the course of performing your job functions on behalf of your agency. They will **NOT** be used for any other purpose outside the scope of your employment/representation.
8. As a condition to the use of ACES materials the ACES Program requires notification by e-mail before or contemporaneous to the introduction of any ACES-related materials, or portions thereof, as a marked exhibit offered for or moved into evidence in any judicial, administrative, legislative or adjudicatory hearing or other proceeding (including discover proceedings) in the United States or any Foreign country. Such notification shall include: 1) the formal name of the proceeding, including docket number or similar identifier; 2) the name and location of the body conducting the hearing or proceeding; 3) the name, mailing address (if available) and contact information of the party offering or moving the ACES material into evidence. 9. You agree to and understand the following **DISCLAIMER**: ACES utilities are available as is and are marked as to version and status (i.e., beta, draft, etc).
